





### WHAT DO YOU NEED TO KNOW

- Use the GPCI's GPC Competency and Skills list to do a self-assessment
- Review the list to evaluate your existing skills, knowledge, and understanding based on your current workflows, tasks, and experiences.
- Generate a "Confidence Level Score" for each Competency using a 1 to 5 scale
- Add up your total score. A score of 0-10 may indicate that maximum study time is needed, 10-20 Keep studying (6-8 months), 20-30 Almost there (2-4 months), 30-35 Ready to Go: start final exam preparations.

### **GPCI WEBSITE: Preparation**

### Preparation

The GPC exam is a generalist test designed for the individual who demonstrates mastery and experience. It is not considered an entry-level exam so a GPC exam candidate should not need to spend a great deal of time studying or preparing. However, studying and reviewing materials may be helpful if you specialize in one area (i.e., you only write federal proposals and not foundation proposals) and need to enhance your knowledge in other areas.

### Competencies and Skills

The GPC Exam is based on the <u>Competencies and Skills</u> developed and continually updated by subject matter experts within the field. It is intended to give employers and contractors an objective view of a grant professional for hire. A review of this document and the skills listed will provide valuable insight to the types of questions typically found on the exam.

#### **GPCI Literature Review**

The GPCI Literature Review may be helpful to GPC candidates looking to refresh knowledge or fill experience gaps in the grants field. This review contains general grant information as well as a list of books, journal articles and websites that may be of interest. Michael Wells, author and grants consultant, originally prepared the GPCI Literature Review as a tool in developing the credentialing examination for use by grant professionals who wish to refresh their knowledge prior to taking the exam.

### Virtual GPC Study Group Guide 2023 Revised February 2025

The methods described in this guide were drawn from my experience facilitating GPC Study Groups for the GPA-Western PA Chapter and the Grants Café, a volunteer-led grant professionals development meetup group.

The first national Virtual GPC Study Group in 2018 grew out of a GPA Forum request for which I volunteered to facilitate group discussions and JulieAnna Carsen, GPC coordinated the virtual technology and communications. We co-produced a GPA webinar and strategy paper and received the GPCI President's Award for our efforts in 2019.

This 2023 Virtual GPC Study Group was a volunteer effort by co-facilitators of the Grants Café <a href="https://meetup.com/grants-professionals-of-western-pa">https://meetup.com/grants-professionals-of-western-pa</a>. I served as the GPC Ambassador and Study Group Coordinator, with facilitation assistance from Laurie Anderson, GPC, Caitlin

### GPC Virtual Study Group | Scenario #2: Organizational Development

Review the GPC Examination Competency #2: Organizational development as it pertains to grant seeking along with the 7 skills associated with this competency.

#### INSTRUCTIONS

**Discussion:** (a) how would you assess the organization's capacity to apply for this grant; (b) what organizational structures and processes affect grant seeking; (c) how does an organization become grant ready; and (d) what steps would you take to assist this organization?

**Multiple Choice Scenario:** As a grant consultant, you have contracted with a nonprofit organization to develop a federal proposal. The RFP fits the mission and services. However, it is the largest amount and most complex proposal they have ever attempted at \$500,000 annually for five years. The requirements are intimidating to staff. Which are the most appropriate strategies for helping the staff?

- Provide a list of electronic resources that staff can review and reference as they address various grant requirements.
- Conduct a workshop with staff to provide an overview of the programmatic requirements.
- 3. Develop a matrix of applicable requirements with management strategies or action steps.
- Meet with staff to determine whether an award so large would justify hiring a full-time management specialist.

### GPCI CANDIDATE GUIDE: HOW TO USE

### Sample Items

The following items represent both the form and content of questions in the examination. These sample items cannot cover all the competencies and skills that are tested, and they can only approximate the degree of difficulty of actual examination questions. However, these items provide the general format of the multiple-choice questions and the writing exercise.

An answer key for the multiple-choice items and samples of acceptable writing responses follow each section of sample items.

### Sample Multiple-Choice Items

- A federal grant recipient is required to gain the funding agency's prior approval for changes to the approved project or budget. The exception is changes to
  - A. key personnel when such persons were identified in the approved project application.
  - B. the scope or objectives of the project when a budget revision is required to implement such changes.
  - C. the scope or objectives of the project when there is no associated budget revision.
  - D. cost categories which represent less than ten percent of the current total approved budget.
- For an effective grant application, the LEAST appropriate strategy for designing the budget would be to
  - A. list each item and increase the cost of each by a negotiations.

### Sample Writing Response - Excellent

#### KIDS TAKING CHARGE

Last year, Youth Services Organization (YSO), a community-based organization with a 35-year history of services to youth identified as "high risk," saw its community's crime rate increase. Crime in Hopeville has always been above the national average, but last year's sharp increase in youth-driven vandalism has caused YSO to create new after-school programming to address and reverse this trend in adolescent crime.

Numerous studies have noted the strong correlation between low academic achievement levels, poverty, and crime. The demographics of Hopeville align with this belief. The poverty rate in Hopeville School District #1 (HSD-1) is among the highest in the city and well above the state mean. While the state average of families living in poverty is 33%, 54% of families enrolled in HSD-1 middle schools live under this hardship. Further exacerbating this disparity in living condition is the neighboring school district, where the poverty level remains at 15%.

#### Sample Writing Response - Acceptable

Schools within our Youth Services Organization (YSO) target area are poor economically and academically. In our three middle schools, 45.5 percent of students live in poverty (range of 42 to 63 percent). That compares to 33 percent of students statewide and just 15 percent of students within our eight neighboring schools.

5,600 students in those nearby middle schools outperform our students BY in Math, Reading, Practical Living, and Science (2006 Kentucky Performance

#### Sample Writing Response – Unacceptable

#### NEED FOR YOUTH SERVICES ORGANIZATION AFTER SCHOOL TUTORING PROGRAM

The youth and schools that Youth Services Organization serves have no after-school tutoring programs, so this is a critical need for our community to help the children read and do math better, otherwise they won't get good jobs when they grow up. Reading and mathematics are key indicators of academic performance as any teacher or principle will tell you, and students who don't learn at grade level need after school programs, besides it keeps them off

### STEPS TO SUCCESS: RECAP

- 1. Eligibility: GPCI Eligibility Quiz and review Candidate Guide
- 2. Prepare to Study: gather resources, develop a study framework, find an accountability partner
- 3. Apply: Gather documentation, complete and submit the packet (consider scholarship opportunities through GPF to assist in exam fees)
- 4. Final review: identify last review needs, practice timed writing, final pass of study materials and resources.
- 5. Exam: Determine if you want to do the exam offsite or at home, schedule your exam times (can do on the same day or separate days), be ready on exam day, rest, dress comfortably and in layers, arrive early, be confident- you got this!
- 6. Celebrate! You completed the exam, and your pass results will come in soon!
