- Is preferably a consumer or potential consumer of the certificants' skills or services.
- Can represent the public's, consumer's, or user's perspective and interest.
- Brings new ideas and goals to the certification board to ensure the public's interest is valued.
- Contributes an unbiased perspective; encourages consumer-oriented positions; and brings additional public accountability and responsiveness.

And the Public Member is Not:

- A current or previous member of the grants profession;
- A supervisor, manager, direct co-worker, or an employee or direct report of individuals in the grants profession;
- An employee of an individual certified by GPCI or an employer of individuals in the Grants profession;

- A person who currently receives or within the last five years has received income from the grants profession.
- An employee of GPCI testing vendor

Expected Time Commitment

- Three year term with ability to serve a second three year term
- One in person meeting at the annual GPA conference
- Monthly two hour conference calls with full board
- Committee meetings as needed.
- May need to attend a board retreat in person.
- Some financial support for travel for meetings.
